- Deadline for retention of numbers: December 15, 2017.
- Ice Racing and Snocross numbers will be issued from December 15, 2017 on a first come basis.
- Youth Motocross riders and Youth Dirt Track Riders who qualify age-wise, may also be eligible for the Novice or Intermediate Class (Check your rule book for conditions).
- Unless otherwise indicated in brackets (), **Minimum** age is 13 on the birthday of the rider.
- Fee – \$80.00 (Youth Class Trials \$30.00)
- After September 1, 2018 Licence Fee for 2018 becomes \$30.00 for all categories.
- Motocross riders who wish to be endorsed for AMA Pro Licences or to obtain an FIM Licence (except Youth class riders) must have Pro status. Eligibility is at discretion of CMA office.

A FULL AND FINAL RELEASE WAIVER OF LIABILITY AND ALL CLAIMS that I have or may in the future have against any person(s), entities, or organization(s) associated in any way with the EVENT including track owners and lessees, promoters, sanctioning bodies, racing associations, or any subdivision thereof, track operators, sponsors, advertisers, vehicle owners and other participants, rescue personnel, event inspectors, underwriters, consultants, and others who give recommendations, directions of instructions, or engage in risk evaluation and loss control activities, regarding the EVENT or event premises, or any one or more of them, and their respective directors, officers, employees, contractors, agent and representatives (all of whom are collectively referred to as "the Releasees") from any and all liability for any loss, damage, injury or expense that my minor child/ward may suffer, or that his/her next of kin may suffer as a result of his/her use of or presence at the EVENT facilities, due to any cause whatsoever. - In the unfortunate event that you suffer an injury at a CMA sanctioned event, it is an insurance and legal requirement that the nature of the treatment you received from the medical crew be reported to us.

Due to the implementation of the Federal Privacy Act, this information will not be sent to us unless we have your consent to do so.

Instead of obtaining your signed consent at each and every event you attend, we ask that you sign and date this form indicating your agreement to provide information.
